

The facts concerning the protection of the personal data of the person concerned in accordance with § 13, 1 of Act no. 18/2018 Z.z. on the protection of personal data

Name of Information System (hereinafter "IS"): Internet portal for sale of stays www.kiskatravel.sk

Personal data are provided by the persons concerned to the information system pursuant to Section 13 Article 1 b) of Act no. 18/2018 of the Personal Data Protection Act (hereinafter "the Act") in accordance with Article 6 (1) (b) Regulations EP and R (EU) 2016/679 (hereinafter "the Regulation")

Processing of personal data of the affected persons - clients in accordance with § 13 par. Article 1 b) of the Act is performed in order to identify the client and the implementation and fulfillment of the pre-contractual and contractual relations - reservation of the ordered stay.

The processing of personal data of the persons concerned for the submission of offers to the client shall be carried out on the basis of a legitimate interest in accordance with Article 6 (1) (f) of the Regulation.

List of processed personal data:

- name, surname, title, state, city, email address, phone number.

Personal data are provided to third parties only in accordance with specific laws, but in particular to the following bodies and institutions:

- the competent court (Civil Procedure Code),
- an intermediary on the basis of a contract pursuant to § 34.

The rights of the persons concerned in the processing of personal data are regulated by the Second part of Act no. 18/2018 of the Personal Data Protection Act. In the case of a request, the person concerned is entitled to have the identity of the person who will process the personal data of his or her identity, or provide additional information such as, in particular, the notification of a specific law (legal basis) under which personal data are processed, provide personal data or what the consequences will be if they refuse to transfer personal data to the operator.

The person concerned also has the right, on written request, to request from the company:

- in a generally understandable form of information about the state of processing of their personal data in the information system
- in a generally understandable form, precise information about the source from which it obtained its personal data for the processing,
- in a generally understandable form, the write-off of its personal data that is subject to processing,
- correcting its incorrect, incomplete or outdated personal data that is being processed,
- Disposal of its personal data if the purpose of its processing has been met; if they are processed by official documents containing personal data, they may request their return
- liquidating its personal data that is being processed, if a violation of the law has occurred,
- Provide access to the records of the relevant information system of the operator, which details the purpose of the processing, the legal basis and the list of personal data.

Portal communication

The Internet portal communicates with its clients via emails. This communication includes news on the portal on the basis of a legitimate interest in accordance with Article 6 (1) (a). (f) of the Regulation. If the user does not wish to send information messages, he may log out directly from the received e-mail from the sending of such messages or request it at kiskatravel@kiskatravel.sk or responder@kiskatravel.sk
